Definitions

Applicant Domicile (overseas country focus)

Applicant's area of permanent residence, which broadly relates to country. The domicile is declared by the applicant by selecting from a list of available domiciles during the application process. In the interest of keeping a consistent time-series, the most recent label for each domicile is displayed across the time series, regardless of the domicile displayed to the applicant at the time of the application. For example, in the 2009 application cycle the label 'Virgin Islands (British)' changed to 'British Virgin Islands', however the report will display 'British Virgin Islands' across every application cycle going back to 2006. Please note: The Channel Islands and the Isle of Man are displayed as separate values, rather than being part of 'United Kingdom'.

Cycle year

The application year in which the application was processed.

Acceptances

An acceptance is defined as an applicant who has been accepted to start a programme through the UCAS Teacher Training scheme.
