### Definitions

#### Phase

The phase the application was made to. The phase may be primary, secondary, middle or other.

#### Applicant Domicile (UK/EU/Not EU)

Applicant's area of permanent residence summarised at a high level. This variable is derived from domicile as declared by the applicant. Split by the following values: 'UK', 'EU (excluding UK)' and 'Not EU'. Please note: The Channel Islands and the Isle of Man have been assigned as 'Not EU'. See the additional technical notes at [www.ucas.com](http://www.ucas.com) for coverage and trends for Scotland.

#### Acceptance route

Apply route through which an applicant was accepted. Applicants may make up to three applications through Apply 1 and one application at a time through Apply 2.

#### Cycle year

The application year in which the application was processed.

#### Acceptances

An acceptance is defined as an applicant who has been accepted to start a programme through the UCAS Teacher Training scheme.
