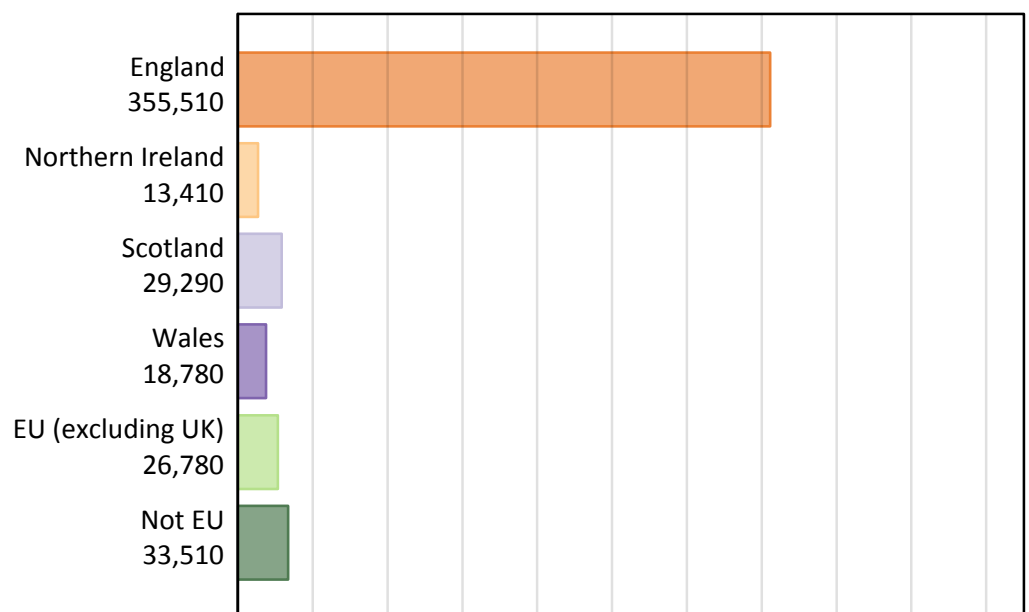


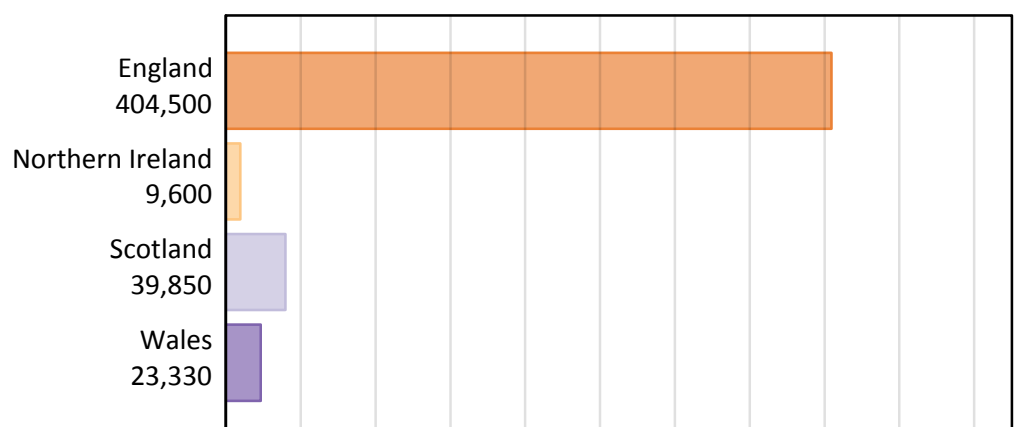

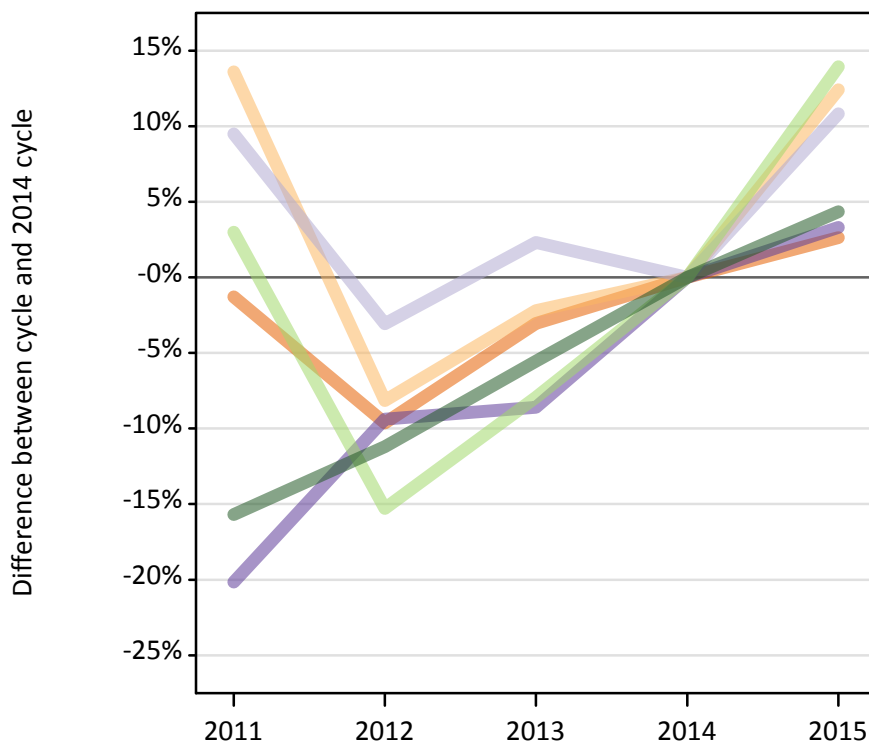
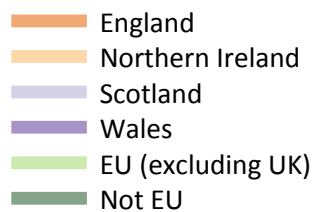


BX.3 Placed applicants by country of provider

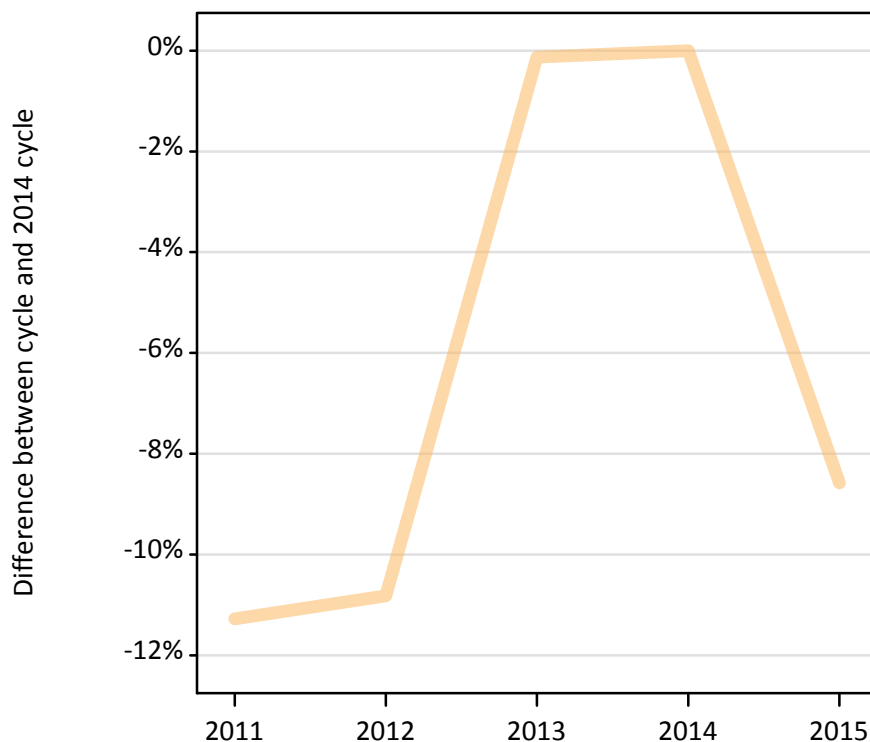

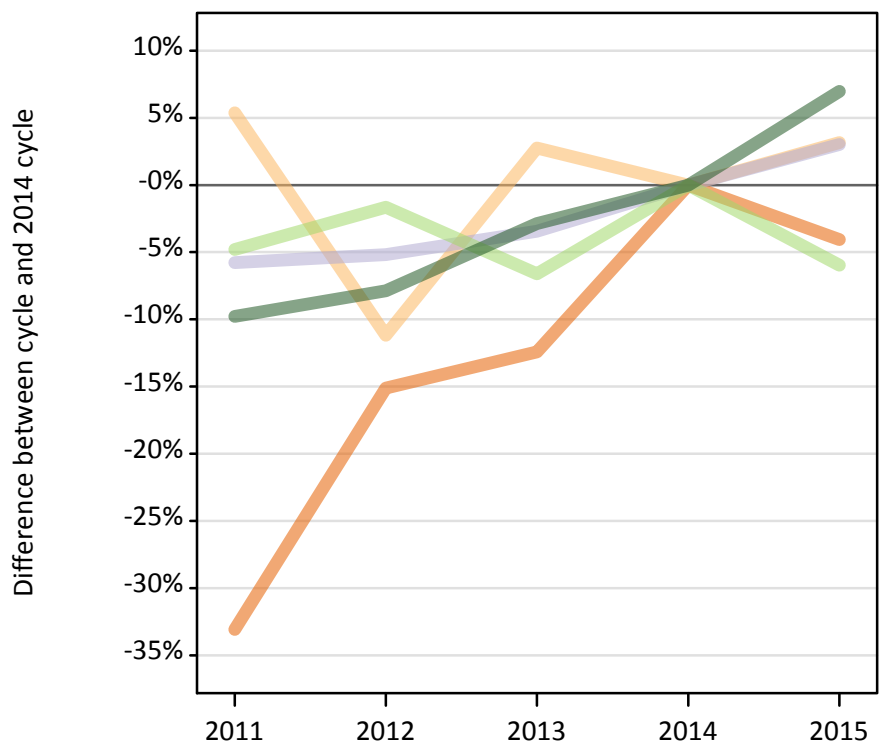

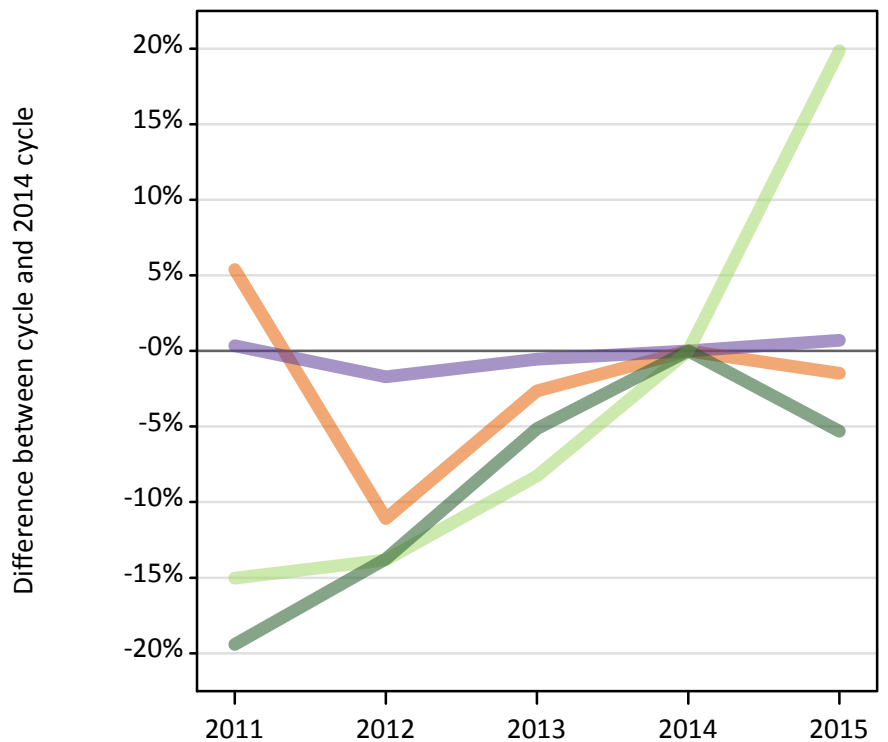

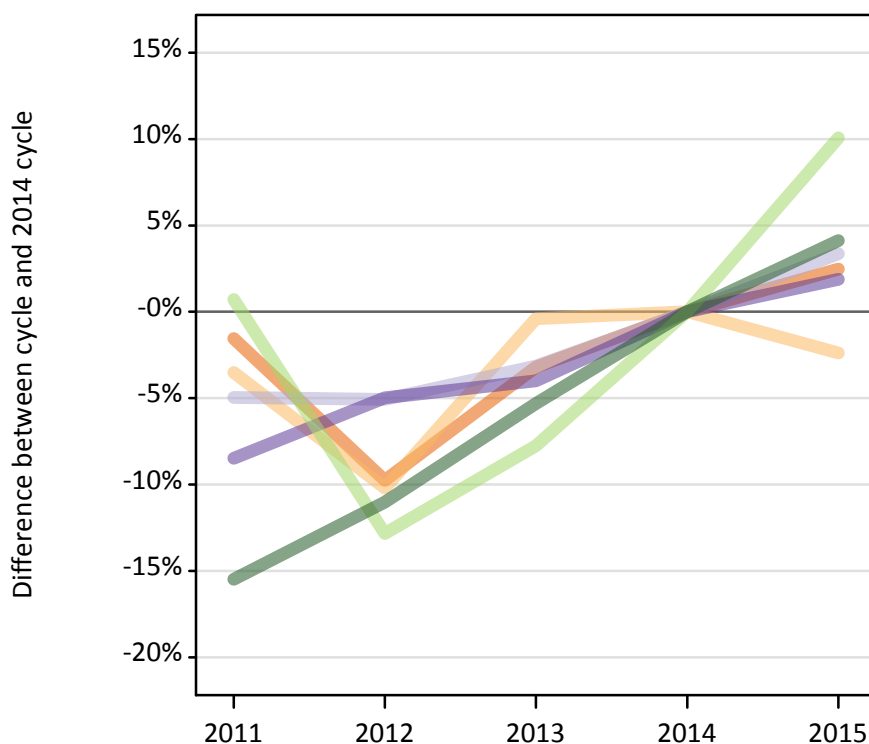
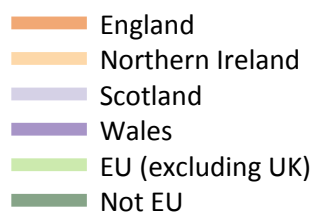
