Purpose

Cambridge IGCSEs are subject-based, and are usually taken over a two year period with assessment at the end of the course.

Education context

Cambridge IGCSEs have been available for use internationally since 1985, with the first exam taken in 1988. They are now the world's most popular international qualification for 14 to 16 year olds.

Cambridge IGCSEs are taught by over 5,500 schools in over 140 countries.

In England they are not funded for use in state schools and do not contribute to Performance Measures.

As an interim measure, they contributed to Performance Measures in England in 2013.

They are used as an alternative to GCSEs in the UK, where Cambridge IGCSE is taught by over 2,600 schools which made over 285,000 entries in June 2015 (of which approximately 18% are independent).

Cambridge IGCSEs are separate from Level 1/Level 2 Certificates; UCAS has published a QIP for these qualifications at <u>https://qips.ucas.com/qip/level-1-level-2-certificates</u>.

For example:

Cambridge IGCSE Biology is externally assessed, with 20% of the total marks allocated to practical skills as either coursework, a practical test, or an alternative to practical paper.

Cambridge IGCSE French is assessed with equal weightings of the total marks allocated to the four skills of listening, reading, speaking, and writing.

All assessment components are entered in a single examination series. If coursework is included in the assessment, it can be completed while doing the course but will not be moderated or externally assessed until the end of the two-year course.

Assessment

Pearson BTEC International Level 3 qualifications are 100% internally assessed through written assignments and practical tasks. Most assessments are set and marked by educators in the school or college and verified by Pearson. Pearson will set and provide centres with assignments for some mandatory units (approximately 25% of all units).
